PPE Product: **HexArmor**® **EXT Rescue Barrier**® **4014** glove that offers cut, puncture and impact protection comprising PVC coated palm, Spandex/poly blend back of hand, waterproof barrier (41% polyester, 23% nylon, 20% polyurethane, 6% cotton, 5% neoprene, 4% PVC, 1% spandex), flared Neoprene cuff with Velcro closure and nylon/polyurethane forchettes. Glove lining comprises of1 layer of HA607P2 SuperFabric sewn into the full palm between PVC coated palm and waterproof barrier. 1 layer of cotton placed over the waterproof barrier (56% polyester, 22% polyurethane, 12% cotton, 10% plastic) Thermal plastic rubber to back of hand impact protection and palm. The glove is available in six sizes: 7 to 12.

When examined the PPE type complies with the applicable essential health and safety requirements detailed in Annex II of the regulations and the relevant requirements in the harmonised standard.
